This book is great since it tracks the Case Book to the T. Every brief that is listed in the Case Book can be located in this supplement. The briefs are written very well and even includes some additional study guides inside the cover.

It seems to conflict with other authority. For instance, it is misleading to state "may be admissible to..." and then goes on to state only a very narrow list of exceptions without stating that any other reasons not listed when it is referring to 411, 410, 408, 407, 409. In reality those listed exceptions are only examples not an exhaustive list as it seems to state.
